President's Report

Last year I commented that the figures in this Table gave cause for concern and unfortunately nothing has improved since then. The continuing decrease may be connected to the fact that last year, 19 of those with unpaid subs were two or more years in arrears. As I commented last year, the figures probably also reflect the reduced focus for Operations Research in CRIs and in some universities. To paint a more positive picture, we can be encouraged by the participation of younger student members of the Society and it is clear that we need to do more to encourage these students to remain active members of the Society when they graduate.

Finances

The 2006 accounts show a healthy state of affairs even though our membership figures are down.

Again I wish to acknowledge the work of our Treasurer, John Paynter, and our Auditor, Paul Rouse, for their sterling work in keeping accurate records of the financial affairs of the Society. Their advice has been much appreciated.

Conferences

Some of you with long memories may recall that last year I indicated that the 2007 ORSNZ conference was scheduled to be held at the University of Waikato and that would be followed in 2008 by a conference at the University of Auckland. Well, of course it is not 2008 and yes, you are at the University of Auckland in 2007.

Unfortunately the decline in interest in OR at Waikato meant that they were unable to organise this year's conference and I am therefore very grateful to Dr Golbon Zakeri who has stepped in and taken responsibility for organising the 2007 conference. I expect that we should signal that because of our reduced rotation cycle, the 2008 conference is likely to be held back in Wellington.

Visitors

The highlight of 2007 has been the visit of Professor Mike Trick from the Tepper School of Business at Carnegie Mellon University on a John Hood Fellowship at the University of Auckland. During his time in NZ he has visited each of the ORSNZ Branches and universities and has done a great deal to promote Operations Research and its relevance in business and industrial settings. His outstanding Hood Public Lecture at the University of Auckland attracted a large audience and the talk was very well received. In September, Dr Gerard Cachon from the Wharton School at the University of Pennsylvania in Philadelphia arrived with his family on sabbatical leave again in the Department of Engineering Science. I hope that before he leaves NZ next June he will have the opportunity to visit the other ORSNZ Branches.

Newsletter

As Newsletter Editor, Matthias Ehrgott has continued to do the "impossible" and extract and generate copy for our Newsletter. Matthias has continued his Newsletter editor role even though he has been on sabbatical leave in France. Along with our annual conference, the Newsletter provides a means of communication that keeps members in touch with both local and international OR news and events. So on behalf of the Society I again thank Matthias for his work.

Council Meetings

During this year a number of issues have been considered and discussed by email Council meetings. While not entirely satisfactory, it is better than not having meetings at all. I do want to acknowledge the work of Hamish Waterer in his role of Secretary in organising the email discussions and decisions.

Acknowledgements

During this year Vicky Mabin indicated that she would not be standing for a position on the ORSNZ Council in 2008. I do want to take this opportunity to pay a special tribute to Vicky and her contribution to the Society over many years. When I came back to New Zealand 33 years ago there was no doubt that the centre of OR mass was to be found in Wellington particularly in the Applied Mathematics Division of what used to be the DSIR. When Vicky returned to New Zealand in the early 1980s after completing her PhD at Lancaster, she joined the OR group in AMD and began her long association with the ORSNZ Council. Over the years she has held the office of President, Secretary, Newsletter Editor and International Liaison, as well as serving on branch committees, and international bodies (APORS, ISIR). On behalf of the Society I want to express our sincere thanks to Vicky for her commitment and all her contributions to the Society over many years.

Finally, I have decided that I should also stand down as President and pass the baton to a younger member who undoubtedly will be able to change the sign of the rate of change of membership. I thank the Society for the opportunity to serve as President of ORSNZ and I look forward to continuing to contribute to the activities of the Society.

Treasurer's Report

The funds available at the start of the period were \$31,000.84. The funds at the end of the period were \$30,844.55. There is a deficit of receipts over expenditure of \$156.29. However two large transactions were receipted in July 2007 as well as subscriptions billed again in June. Thus the deficit reflects timing issues rather than a decline in the accounts (although the true surplus is only half of that for the previous financial year).

2006 conference made a small loss, but this included the production and postage of the conference proceedings sent to members. Other expenditure was under budget due to cost containment. Only Auckland had a function (subsidised by Engineering Science) for a widely publicised and well-attended talk by Mike Trick. The other branches will have a similar opportunity when he visits in the new financial year (there was no corresponding visitor expense in 2006-2007).

The term deposits were consolidated into one to get a better interest rate and to save data entry in the second half of the financial year (matures 2 Jul 2007). Hence interest income is up. It and the GST return show up in the 2007-2008 accounts at the beginning of the new year (July).

We still have a surplus from the MinandMax project of \$676.15 (the production of a poster and brochures to promote Operations Research in schools). i.e. nothing was spent in the last two financial years.

The upgrade of the accounting system was justified in the painless reconciliation of the accounts throughout the year, although some fine tuning is still possible. It had been hoped that a student could be obtained for Summer School to interface the system to BNZ Merchant services. BNZ have changed its process – we now require authorisation numbers for every (manual) transaction and can only process 5 at a time in this way.

An interface between the conference registration system and the accounts would also save on data entry.

Banking of cheques by recipients was more timely in 2007. As a consequence there are no unpresented cheques at the end of the financial year. This speeds up auditing. However writing a series of reminder letters to pay subscriptions (even though we aim to time them with the newsletter) costs office holders time and the society money.

Auckland Branch Report

The Auckland Branch of ORSNZ continues to be active. On May 17th the Branch hosted a social occasion after the John Hood Invited Lecture by Mike Trick entitled: "Operations Research: The Science of Better". This lecture, reported on elsewhere in this Newsletter drew an audience of approximately 100 people from the Auckland region. It was very gratifying to see such a large turnout. Gazing around the audience, this correspondent noted Phil Bishop from the Electricity Commission who had flown up from Wellington, Jim Corner who had come up from Hamilton for this talk, Merv Rosser, who we all know as a life member of ORSNZ, Jeff Meyer and Cory Williams from Optima Corporation, the Engineering Science graduates who now work in Derceto, and Geoff Leyland from Incremental. There were also many people there I did not know, who evidently work in Auckland in an OR-related field. Mike's lecture was stimulating, informative, and amusing.

The evening was rounded off well with a social function sponsored by ORSNZ. A number of enquiries were made at this function about the Society and its purpose. Most gratifying was seeing the number of people at the talk who now work in an OR related field – enough to want to come and hear such a talk. The challenge for the Society is to encourage the same people to come and present what they are doing at the ORSNZ Conference.

On November 28, the Auckland Branch of ORSNZ and the Department of Engineering Science will host a one-day invited workshop on Modelling Competition in Supply Chains in conjunction with the ORSNZ Conference. This is to coincide with the visit of Gerard Cachon, who is Fred R. Sullivan Professor of Operations and Information Management at the Wharton School. He is visiting the Department of Engineering Science until June 2008. Gerard's interests encompass most of Operations Management (he is joint author of the textbook "Matching Supply with Demand: An Introduction to Operations Management") and he has published widely in the field. His recent research focuses on understanding how supply chains work in practice, and how their observed operation can be explained using game-theoretical models. With Professor Mike Trick (who is in Auckland until December) Gerard will be a plenary speaker at the ORSNZ Conference in Auckland on November 29 and 30.

The Auckland Branch celebrates the success on November 15 of our corporate sponsor Optima Corporation in winning a Technology Commendation by the Foundation for Research, Science and Technology in recognition of outstanding achievement in designing and applying cutting-edge technology in developing the SIREN software system for ambulance simulation.

President of ORSNZ, Professor David Ryan has been elected a Fellow of INFORMS. He travelled to Seattle in early November to be formally inducted into the INFORMS Fellowship. This is a great honour for David and for ORSNZ, and we extend him our warmest congratulations.

A huge vote of thanks to Vicky for her tireless work over many years for the Wellington branch and ORSNZ. Congratulations also to Bob Cavana for a bumper year of publications including the second edition of his "Systems Thinking, System Dynamics" book.

It is also encouraging to hear of the successes of former students. Two recent OR graduate students from VUW, Sarah Marshall and Tineke Poot, have joined the PhD programme at Edinburgh University. Sarah and Tineke both benefited from giving student talks at past ORSNZ conferences.
